- ❖ All Divisions – Wet matches will be rescheduled after week 14. If a rescheduled match is rained out, it will not be played, and points will be shared.
- ❖ The Semi-Final for Division 1 will be played while Division 2 and 3 play Match 15.
- ❖ Finals for all Divisions will be played the following week.
- ❖ Tuesdays from 9.30am till 3.00pm - 4 ladies per team play each day, with each lady playing 4 sets of doubles. 8 sets of first to 6 games with a tiebreak at 5-all. No Play during NSW public school holidays.

#### **Scoring:**

Our Competition will be run using the Xpoint Sports scoring system [www.xpointsports.com](http://www.xpointsports.com).

**Home teams are responsible for entering match scores into Xpoint Sports.** Scores are to be entered within 24 hours if easier than on your phone at the courts. **Note:** you must be logged into [xpointsports.com/login](http://xpointsports.com/login) to be able to set team players and enter the match scores.

#### **NOTE: 2025 SUMMER Competition rules DIV. 2 AND 3 ONLY**

#### **Borrowing of players:**

*Division 3 may borrow players from Division 2 only under exceptional circumstances and the Competition Secretary must be advised of that borrowed player and reason.*

Players are permitted to be borrowed

1. Firstly from the Pool or within the grade.
2. Secondly only if all avenues are exhausted Division 3 may borrow a Division 2 player from any team **once only** per comp No Div. 2 players are eligible for final series in Division 3.

3. Once only players can be used as per the Rules & By-Laws

**Team Registration Entry Form** plus **team entry fee** \$120 as at 1 December 2024 may be subject to change and must be received by the Pro Shop Staff on or before the Semi-Final date. Each player must be a Member of NWST (fee as at 1<sup>st</sup> July 2024, \$55 Adults & \$50 Seniors). Registration fee is due Day 1 of play and then paid annually by 1<sup>st</sup> July. Fee may be subject to change annually as determined by NWST Executive committee

**Competition Match Fee** will be **\$40 per team** per match, and **Home Team** will be provided with **3 new tennis balls**, in line with other Competitions. **Away team** will be provided with the Result Card on payment.
