COMPETITION GENERAL INFORMATION:

- ❖ All Divisions – Wet matches will be rescheduled after week 14. If a rescheduled match is rained out, it will not be played, and points will be shared.
- ❖ The Semi finals for all divisions will be played after week 14 inclusive of rescheduled matches as applicable
- ❖ Finals for all Divisions will be played the following week.
- ❖ Tuesdays from 9.30am till 3.00pm - 4 ladies per team play each day, with each lady playing 4 sets of doubles. 8 sets of first to 6 games with a tiebreak at 5-all. No Play during NSW public school holidays or dates as gazetted by NWST..

Scoring:

Our Competition will be run using the Xpoint Sports scoring system www.xpointsports.com.

Home teams are responsible for entering match scores into Xpoint Sports. Scores are to be entered within 24 hours if easier than on your phone at the courts. **Note:** you must be logged into xpointsports.com/login to be able to set team players and enter the match scores.

PLEASE NOTE: 2026 Competition rules

POOL PLAYERS:

Players are permitted to be borrowed

1. Firstly from the Pool or within the grade. **Please note Pool players are permitted to ONLY play 3 times for a team as a pool player. If a 4th game is played they will be required to join that team and therefore ineligible to be a Pool player.**
2. Once only players can be used as per the Rules & By-Laws

Team Registration Entry Form plus **team entry fee \$120** as at 1 June, 2026 which may be subject to change and must be received by the Pro Shop Staff on or before the Semi-Final date. Each player must be a Member of NWST (**Fee as at 1st July 2026, \$59 Adults & \$54 Seniors**) which may be subject to change. Membership fee is due Day 1 of play and then paid annually by 1st July. Fee may be subject to change annually as determined by NWST Executive committee

Competition Match Fee as at 8 July 2026 will be **\$40 per team** per match, and **Home Team** will be provided with **3 new tennis balls**, in line with other Competitions. **Away team** will be provided with the Result Card on payment.
